Sealed bids will be received by the El Paso Water Utilities until **2:00P.M.**, local time, **July 6, 2017**, Bid Number **30-17** for **Canutillo Wastewater Vacuum System Replacement Project - Phase I Crystal Marie Gravity Main** in accordance with plans and specifications. Bids will then be opened and read aloud in the third floor conference room, El Paso Water Utilities Building, 1154 Hawkins Boulevard, El Paso, Texas 79925.

The work under this contract shall be for furnishing all labor, materials, transportation and services for the construction and installation of the following work:

The Canutillo Vacuum System was originally constructed in 1999 in Canutillo, Texas. The age, deteriorated conditions and frequent repairs of the system has been problematic during recent years. The EPW has determined that immediate system modifications are required to allay current operational problems. The EPW has elected to remove the existing services located the furthest distance from the existing vacuum pump and lift station, the scope of the **Project** is briefly described below:

Insurance, Bonds, and Move-In Related Expenses, Not to Exceed 5% of Total Bid.

Maintain operation of existing system throughout construction to include existing vacuum system and vacuum valve pits and service connections.

Perform Project Dewatering as required for construction.

Install approximately 3,210 linear feet (lf) of 12-inch sanitary sewer gravity main; approximately 895 lf of 8-inch sanitary sewer gravity main; 15 Type A Manholes.

Install 445 lf of 24-inch bored steel casing.

Install 34 sanitary sewer service with clean-out and approximately 1,100 lf of 4-inch sewer main for connection to the new gravity main.

Upon start-up of the new gravity system and service connections, remove approximately 23 valve pits and equipment for salvage to EPW at 700 South Boone Street.

Furnish and install Trench Safety for the project.

Remove and dispose of approximately 1,450 square yards of existing asphalt pavement; and replace with approximately 1,450 square yards of new pavement 12-inches of 2 sack base course and subgrade prep; approximately 1,600 cubic yards of two sack backfill and approximately 400 square feet of concrete driveway.

Provide TPDES permit and project traffic control to include coordination with the County of El Paso Road and Bridge Department.

Maintain As-built drawings and provide Construction Progress Photos.

Provide Site Security and dust control.

Protect existing utilities and services.

Provide project safety in accordance with all latest Occupational Safety and Health Administration (O.S.H.A.) requirements as the work dictates.

PRE-BID MEETING will be held at **2:00 P.M.**, local time, **June 21, 2017**, in the third floor conference room, El Paso Water Utilities Building, 1154 Hawkins Boulevard, El Paso, Texas. The purpose of the PRE-BID MEETING is to review the plans and specifications and respond to questions from bidders.

Qualified Local, Minority and Women Enterprises are encouraged to participate in this project and will be contacted by the bidder by certified mail wherever possible. Certified receipts shall be provided as part of the bid unless the goal has been reached as evidenced by draft subcontracts included with the bid or other evidence the goal has been attained. The Utility's minimum goals for this project are: 15% for Small Locally-Owned Businesses, 5% for Minority-Owned Businesses, and 2% for Women-Owned Businesses.

Each Bid shall be submitted in accordance with the Instructions to Bidders and be accompanied by a Bid Security in the amount of five percent of the bid amount.

Contract Documents, including plans, specifications and proposal forms may be examined without charge in the office of the Purchasing Department, 1154 Hawkins Boulevard, El Paso, Texas 79925 (FED-X address) or may be obtained from the same address **upon receipt** of a non-refundable payment of **\$50** for each hard copy of Contract Documents and/or a non-refundable payment of **\$7.50** for a CD version of the Documents.
