Sealed bids will be received by the El Paso Water Utilities until **2:00P.M.**, local time, **December 14, 2017**, Bid Number **94-17 for North 2 to Franklin East 1A & 1B-36"/24" Water Lines Phase II** in accordance with plans and specifications. Bids will then be opened and read aloud in the third floor conference room, El Paso Water Utilities Building, 1154 Hawkins Boulevard, El Paso, Texas 79925.

The work under this contract shall be for furnishing all labor, materials, transportation and services for the construction and installation of the following work:

Furnish and install approximately 2,555 LF of 36" and 2,830 LF of 24" diameter potable water transmission main, including isolation valves, air/ vacuum valves and blow-off valves and fittings. The project includes 410 LF of 54" steel casing crossing TXDOT ROW (US Highway 54) by jack/ bore/ tunnel method of installation. All other pipeline installation will be by open cut and include excavation and bedding. The project will include trench safety per OSHA requirements, disinfection, storm water pollution prevention measures, project-wide traffic control, construction water and power, installation of gabion mattresses, dust control, project management, mobilization, demobilization, house-keeping and project videotaping for a complete and operable project as intended by the drawings and specifications.

PRE-BID MEETING will be held at **10:00 A.M.**, local time, **November 30, 2017**, in the third floor conference room, El Paso Water Utilities Building, 1154 Hawkins Boulevard, El Paso, Texas. The purpose of the PRE-BID MEETING is to review the plans and specifications and respond to questions from bidders.

Qualified Local, Minority and Women Enterprises are encouraged to participate in this project and will be contacted by the bidder by certified mail wherever possible. Certified receipts shall be provided as part of the bid unless the goal has been reached as evidenced by draft subcontracts included with the bid or other evidence the goal has been attained. The Utility's minimum goals for this project are: 15% for Small Locally-Owned Businesses, 5% for Minority-Owned Businesses, and 2% for Women-Owned Businesses.

Each Bid shall be submitted in accordance with the Instructions to Bidders and be accompanied by a Bid Security in the amount of five percent of the bid amount.
